WHY AN ASSEMBLY?

grown up in an unaffiliated nondenominational church context. "church" to me was always synonymous with the congregation: the people who gather together on Sundays, share coffee hours and sometimes meals, and know each other's names and stories. While this is undoubtedly the most significant manifestation of church for Christians, it is not the only reality encompassed by the word. In the creeds that we confess together most Sundays, we affirm our belief in the "holy catholic (meaning universal) church." This is a profound statement of belief, claiming that all followers of Christ around the world are part of one church.


Even in a globalized reality with the possibility of real-time communication with people around the world (including our own music director who is living 11 time zones away from us at the moment), we do not often get to experience the shared identity and purpose of the church beyond our immediate community. However, once a year we have the chance to experience being church with other members of our comprising 200 Synod. about congregations. Of course, there are logistical necessities for the Synod including Assembly, constitutional requirements, but there are also deeply spiritual purposes as well.

Worshipping together reminds us of the unity of our faith. Debating resolutions together helps us to practice the work of careful listening and discernment. Passing a budget together requires that we connect our money with our values. Electing a new bishop allows us to ask big questions about our collective mission and vision as Christ's church in this time and place.

Of course, the "us" in all of those observations will only include members of our congregation (myself, Tyler Rice, and Heather Nilsen, this year), but I hope that no member of our congregation feels like the Synod Assembly is irrelevant to your lives as a result. The New Jersey Synod is your Synod, your church. We are united in mission and in resources in important ways. The next Bishop will be a leader for our church in casting a vision for moving forward in a context that makes less and less room for faith communities, and for empowering us to love boldly in that reality. So even if you will not be actively participating in the Synod Assembly this month, I hope you will see it as a reminder that our church is so much bigger than Abiding Peace. Please pray for the work of the assembly, and be encouraged that we are church together.

NOTES FROM COUNCIL

Council met on May 18, focused primarily on a detailed review of Constitutional updates. Key points from the meeting:

Budget:

- April was a positive month with a \$3,342 surplus, helping to erase some of the year-to-date deficit (now at just over \$5,700)
- Agreed to share the budget update at the June Congregational Meeting.

Constitution Update:

- Edits and reformatting to bring the church's constitution into compliance with the ELCA model constitution were approved, with discussion of all discretionary components.
- Congregational meeting scheduled for June 29 th to present the updated constitution to the congregation for a vote.

Partnering Effort:

 Given challenges with finding a building partner through our own efforts, Council discussed the option of using a property management vendor to find a renter. Up-front costs are significant once a renter contract is signed, so we will discuss at the Congregational meeting.

Pastor's schedule:

 Given significant overtime in the Spring, Pastor will be taking some mid-week comp time over the summer (July 8-12). She will also be serving as the camp Chaplain at Crossroads from July 28-August 2; doing her continuing education week August 11-17; and taking a family vacation August 25-Sep. 2.



Update on our Investing to Thrive Campaign

This month of June is the final official month of our Investing to Thrive campaign which began in mid-2024. Our generous community has pledged a total of \$54,250 toward the two phases of the campaign, and as of April 30, with two months remaining, we have received \$46,681. Thanks to all who have contributed! If you have not yet met your pledge and are able to, please do so by June 30. If you would like more time or need to lower your pledge, please update our Financial Secretary Nita Persson. To contribute stocks or other securities, contact Ray Mueller.

Here are the two goals that the funds being raised are going towards:

Level 1 - to ensure a safe and welcoming space, for ourselves and partners

This goal to raise \$35,000 has been met. Most of these funds are going towards two new air conditioning units. They have arrived and will be installed soon, in time for summer. Also we have new parking lot lights, did some painting and repairs, and will do patio sealing and window repairs with these funds. We have secured prices on all the projects totaling less than the \$35,000 anticipated cost.

Level 2 - strategic stewardship for longer-term investment in our property

Funds continue to come in for this goal, to be allocated among these investment categories:

- Building renovation and repairs
- · Additional mortgage buy-down (\$5,000 has already been designated and used for this)
 - · Begin a parking lot repair fund
 - Other priorities, if approved by the congregation.

Remember that gifts to Investing to Thrive are intended to be in addition to our regular support of Abiding Peace, and we encourage them to be from sources that are not part of our regular household budget such as tax refunds, investments, etc. But in all the ways that you support our congregation, thank you for your faithful stewardship!
